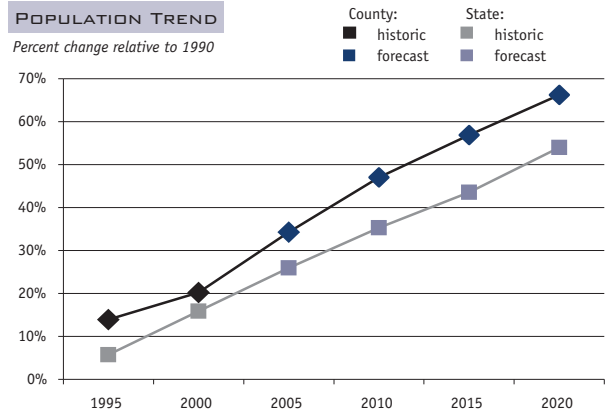

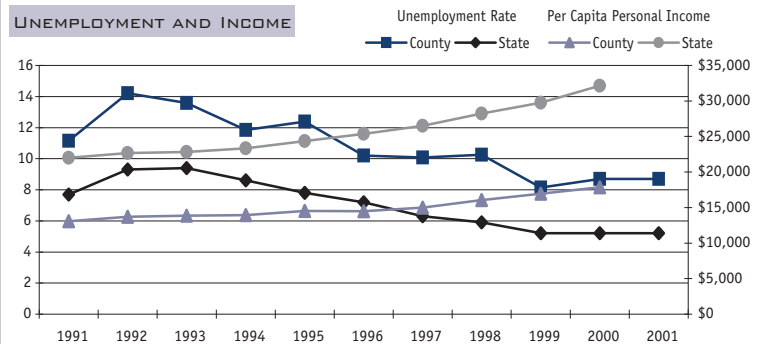

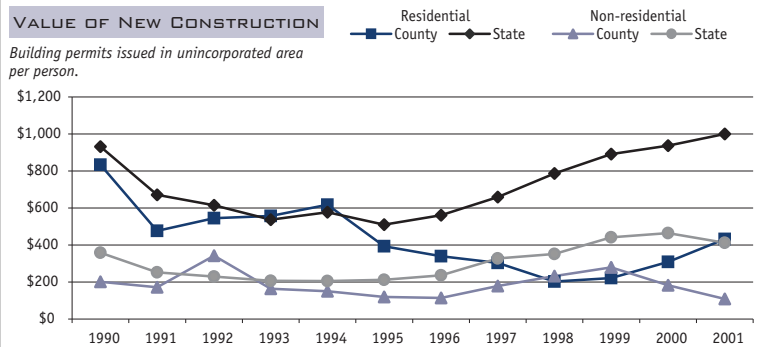

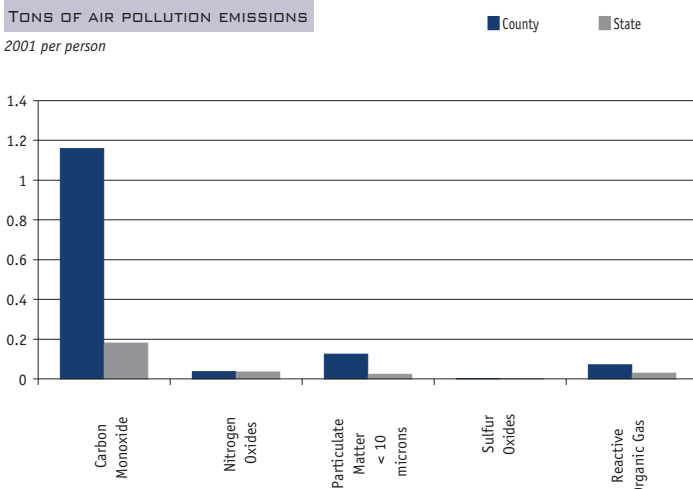
VALUE OF NEW CONSTRUCTION

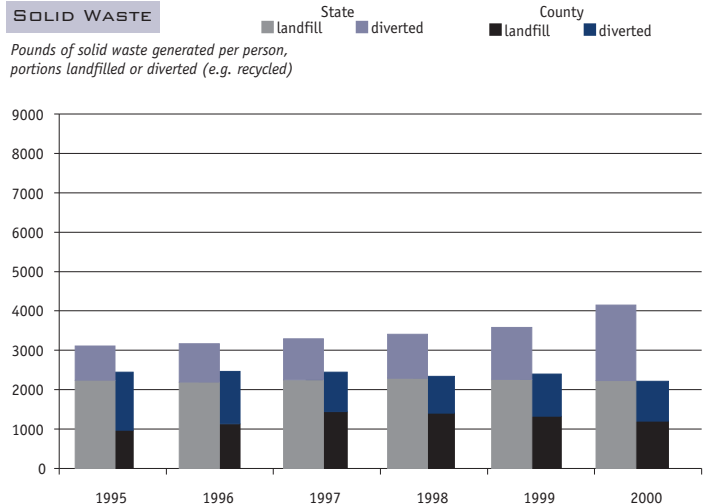
TONS OF AIR POLLUTION EMISSIONS

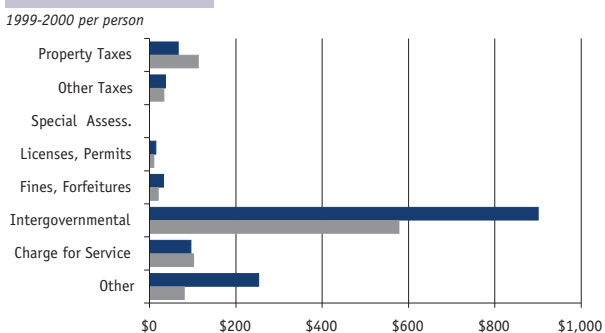

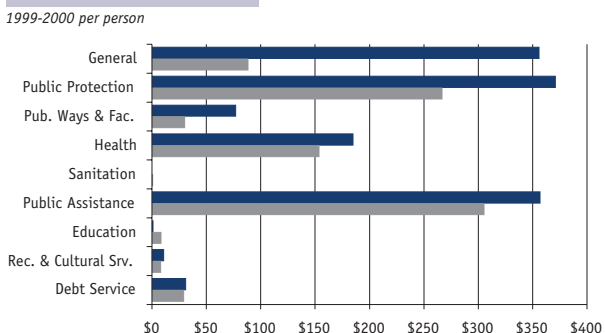

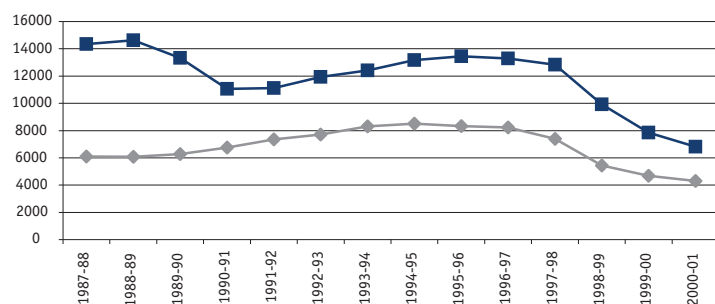

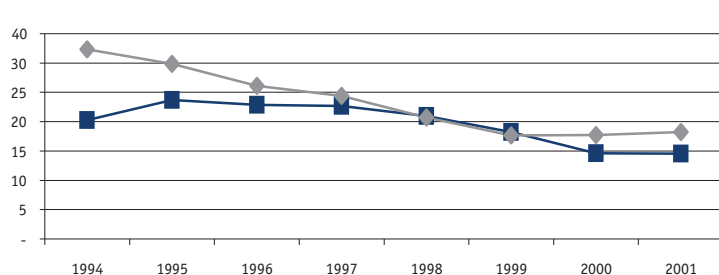
Fiscal years 1987-88 through 2000-01, per 100,000 population
